

## Paper tax return guide for tax year **2017-18**

### Who is this guide for?

Parents or partners who:

- have been asked to supply financial information in support of a student finance application for academic year 2019/20 **and**;
- completed a paper tax return for tax year 2017-18.

### What is this guide for?

This guide will tell you where to find the information you need on your paper tax return to help you complete the 'Financial details for tax year 2017-18 for parents and partners' section of the main application form.

### How to use this guide

The income and deduction types are listed below in the same order as the form you're completing. For each income or deduction type we've provided a reference to help you find that amount on your paper tax return.
